Item 1(a). NAME OF ISSUER:

The name of the issuer is Mallinckrodt plc, an Irish entity (the "Company").

The Investment Manager serves as the investment manager to Hudson Bay Master Fund Ltd. and HB SPV I Master Sub LLC, in whose name the securities reported herein are held. As such, the Investment Manager may be deemed to be the beneficial owner of all securities held by Hudson Bay Master Fund Ltd. and HB SPV I Master Sub LLC. Mr. Gerber serves as the managing member of Hudson Bay Capital GP LLC, which is the general partner of the Investment Manager. Mr. Gerber disclaims beneficial ownership of these securities.
